The vacation rental industry is becoming increasingly competitive...

Many homeowners and commercial property owners are **entering the short-term rental market**, attracted to its income potential and **low barriers to entry**

Guests now have **too many** rental options with **fewer areas of differentiation** for competing hosts

Easier to enter the market as properties do not require commercial ratings (i.e., hotels that must being inspected by the U.S. Fire Administration and other bodies)

Unsafe vacation rental experiences are proliferating the vacation ecosystem, adding a new level of complexity & caution to guests looking for safe travel destinations

Vacation rental managers (e.g., AirBnB, VRBO, Booking.com) do not have stringent security & safety requirements for new & existing hosts (currently self-regulated)

Increasing focus on **safety** and **compliance** creates an opportunity for hosts to differentiate their offerings to guests

Creation of a Standard Assessment Framework

- GuestGuard team introduces hosts to a standardized inspection rubric, tailored to optimizing the short-term vacation rental guest experience
- GuestGuard establishes a user-friendly roadmap to bridge initial onboarding for a host to becoming fully certified
- Hosts remain in the GuestGuard ecosystem with access to ongoing support and educational resources as they go through the annual inspection process

Partnerships with Government & Insurance

- GuestGuard to collaborate with local safety resources to establish best practices for hosts & guests
- Input from state representatives and industry experts to best prepare for any future rental property regulation
- Establish synergies with property insurers to recognize features
 & benefits of carrying the GuestGuard certification

Introduction of the Host to the Inspector Network

- Once a host is onboarded, introduction is made to local inspectors who assesses the property on the GuestGuard rubric
- Detailed inspections are carried out, encompassing safety & security (e.g., fire safety, building security, child safety, neighborhood safety), rental property condition, and actual facilities available to a guest
- Host publishes rating on listing and works with inspector on any remediation actions

Guest Access to the GuestGuard Universe

- Guests subscribe to a web-based showcase of rental properties which have been empirically assessed for quality & safety
- Prospective users can browse the web portal for content and news items pertaining to the industry
- Upon subscription, users would have access to the full continuum of certified properties, their assessments, and results; if paying a one-time fee, guest would have access for a single transaction


Labor Management: Proposed Partnerships



GuestGuard is seeking partnerships with national inspector groups to build a market-leading service network

Partnership Overview

- GuestGuard is seeking to partner with regional and national home inspector groups to link qualified professionals with millions of short-term vacation property hosts
- Partnerships (such as one with the InterNACHI¹) would allow for streamlined credentialing, supplemental education, and insight into the inspection market (and any potential changes in regulations)
- GuestGuard would seek to onboard and coordinate qualified inspectors through KPA (see following page), which would track and allocate jobs to the network
- Partnerships represent a massive revenue opportunity for qualified inspectors, while ensuring GuestGuard hosts & guests feel safe in every stay on their premises

KPA Overview

- Full end-to-end inspector management platform providing real-time tracking and inspecting of host properties
- Actively monitors compliance of inspectors and their ability / eligibility to conduct property audits to specific homes
- Automatically sends digital notifications of non-compliance to property hosts, allowing them to plan their next inspection / remediation visit to stay up-to-date safety & security compliance
- Provides daily assurance that hosts are eligible and compliant, and that homes are fully functioning and safe, giving peace of mind to vacationing guests and local regulators
